Effectiveness of Implementing the Duties and Functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep District

Abstract

This research aims to determine the level of effectiveness, determine the supporting and inhibiting factors and the efforts made to increase the effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency. The population in this study was the people of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, consisting of the village head, all village officials, the RK head, the RT head, and 35 community leaders. In this research, a total sampling technique was used so that the number of samples was the same as the population. The data analysis used in this research is quantitative descriptive analysis. The results of the research show that: 1) The effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency is on average 2.80 or is in the effective category; 2) Factors that support the implementation of the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency consist of: a) Bhabinkamtibmas controls the area of its duties; 2) Availability of supporting facilities and facilities; 3) Community support, while the factors that hinder the implementation of the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency consist of: a) a fairly large working area and b) Topography of Bulu Tellue Village; 3) Efforts made to increase the effectiveness of the implementation of the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, include: a) the need for synergy and cooperation between Bhabinkamtibmas and the village government; b) encourage and increase support from the entire community at large and in general.

1. Introduction

A sense of security in the environment where we live is absolutely absolute and we must obtain it in order to create a peaceful environment. This feeling of security can arise if every element of society living in that area is willing to protect it. If a sense of security has been achieved then people in the environment can carry out their activities normally and peacefully. The security forces include the police, security guards and Hansip/Linmas. However, what will be discussed in this research is the Republic of Indonesia Police apparatus, considering that it is the main task of the Republic of Indonesia State Police to maintain security and order as well as being Protectors, protectors and servants of the community as well as law enforcers in the State of

Indonesia in accordance with Article 22 of 2002 concerning National Police of the Republic of Indonesia.

The Indonesian National Police (Polri) is an institution responsible for seeking, preventing and eliminating any symptoms that may arise and could disrupt security and order in society. The National Police certainly has quite a tough task in preventing violations, crimes, providing community services, and protecting and ordering society. The main duties of the Indonesian National Police are: (a) maintaining security and public order; (b) enforce the law; and (c) provide protection, protection and services to the community. Moreover, in areas that have the potential for high crime rates, such as urban areas or at the district level.

The task of the National Police in maintaining security and public order is to try to maintain and maintain the condition of society so that it is free from fear and worry so that there is a sense of certainty and guarantee of all interests and is free from violations of legal norms. Efforts used through preventive and repressive efforts. The preventive task is carried out with the concept and pattern of coaching in the form of providing guidance, protection and services to the community so that the community feels safe, orderly and peaceful and is not disturbed by all its activities. Preventive steps are efforts to prevent the meeting of intentions and opportunities to do evil so that crime and criminality do not occur.

Bhabinkamtibmas is a member of the police who is appointed as a supervisor of security and public order. The goal to be achieved in Bhabinkamtibmas activities is the realization of a stable and dynamic social security situation in order to secure and make national development a success. Meanwhile, what is meant by kamtibmas is a dynamic condition of society which is characterized by ensuring order and upholding the law and maintaining peace which contains the ability to foster and develop the potential and strength of society in warding off, preventing and overcoming all forms of law violations and other forms of disturbance that can be disturbing. public.

It is hoped that the kantimbmas situation will be realized by all members of the community, thereby giving rise to a feeling of peace and tranquility in every community and increasing motivation and enthusiasm for work, because there is no fear due to possible disturbances that will befall Ramadhan (2018: 132). The National Police has quite a difficult task in preventing violations and crimes, resolving social conflicts in society as well as providing services to the community and protecting and ordering society.

Bhabinkamtibmas has a very strategic function and role in realizing a partnership between the police and the community, so that together they are able to detect symptoms that can cause problems in the community, are also able to find solutions to anticipate problems and are able to maintain security and public order. Bhabinkamtibmas can be said to play an important role in law enforcement, resolving or resolving social problems that occur in society. Bhabinkamtibmas has a role as a mediator, negotiator and facilitator in resolving problems that can still be

measured by the severity of the error and can be resolved by peaceful agreement and consensus, also looking at the customary laws that exist in each place.

Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency is one of the villages where social problems sometimes still occur which are symptoms that exist in social life in a society which are felt as a burden or nuisance that is detrimental to community members. These detrimental disturbances include violations of the law, violations of religious norms, violations of customary norms, and violations of other social norms. These legal violations can cause conflict and disturbance for other people and can lead to clashes between community groups. This is where the role and function of Bhabinkamtibmas acts as a dispute mediator or as a person who facilitates dispute resolution.

Some things that are often anticipated by Bahbinkamtibmas are a lot of fake news (hoaxes), the circulation of mixed alcohol, gambling, drug abuse, and brawls between residents, causing unnecessary anxiety, then issues of radicalism that can disturb the community. With the existence of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, it has had a good impact in realizing security and public order, several forms of activities carried out by Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, such as patrol activities at night, socialization activities regarding enforcement law in society as well as various other activities that seek to create security and public order. Thus, with the existence of Bhabinkamtibmas, the National Police in this case must be able to build close and friendly social interaction with the community, namely its existence becomes a symbol of friendship between community members and the police by prioritizing and understanding the need for a sense of security among community members, which prioritizes crime prevention measures (crime prevention).

Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency needs the role of Bhabinkamtibmas to provide comfort, order and security in the Bulu Tellue Village environment, Tondong Tallasa District, Pangkep Regency, so that the community's expectations regarding the role and function of Bhabinkamtibmas can run optimally and can realize the community of Bulu Tellue Village, Tondong District Tallasa Pangkep Regency is orderly and safe.

This research aims to determine the level of effectiveness, determine the supporting and inhibiting factors and the efforts made to increase the effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency

2. Method

The type of data in this research consists of quantitative data. The data sources in this research consist of primary data, namely data obtained from questionnaires and interviews, while secondary data is obtained from documentation. The population in this study was the people of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, consisting of the village head, all village officials, the RK head, the RT head, and 35 community leaders. In this research, a

total sampling technique was used so that the number of samples was the same as the population. The instrument in this research was to use a questionnaire which was distributed to respondents using a Likert scale which had three answer choices. The level of measurement for these three variables uses an ordinal scale. The data that has been collected from the respondents' answers will be processed using a data tabulation system.

3. Result

3.1. Description of Research Respondents

Gender




Figure 1 Description of Respondents Based on Gender

Level of education




Figure 2 Description of Respondents Based on Education Level

Bhabinkamtibmas are police officers who are specially assigned to Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency as their target area by partnering with the community who have various tasks.

This shows that the implementation of the Bhabinkamtibmas function in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, which consists of Bhabinkamtibmas guiding and counseling in the field of law and Kamtibmas in order to increase awareness of law and Kamtibmas by upholding human rights or human rights, Bhabinkamtibmas disseminating various information regarding policies the leadership of the National Police which is related to the Maintenance of Public Security and Order or Harkamtibmas, Bhabinkamtibmas encourages the implementation of environmental security systems and community activities, Bhabinkamtibmas provides police services to communities in need, Bhabinkamtibmas mobilizes positive community activities, Bhabinkamtibmas coordinates

The table above shows that the average recapitulation of the implementation of the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency is 2.80 or is in the effective category. This shows that Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency has carried out its duties and functions effectively.

4. Discussion

4.1. Effectiveness of Implementing the Duties and Functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency

Implementation of Bhabinkamtibmas Duties in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency

The results of the descriptive analysis show that the average effectiveness of implementing Bhabinkamtibmas duties in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency is 2.76 or is in the effective category. This shows that all the duties of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency have been carried out effectively, as the results of an interview with the Head of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency (Mr. Hariadi) stated that: Bhabinkamtibmas visits residents' homes almost every today, this is done to find out the current situation and conditions developing in the community and to find out the problems and desires of each resident (Interview on Friday, August 25 2023).

Based on the interview above, it shows that Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency has carried out its duties by making visits to residents' homes as stated in National Police Chief Regulation Number 3 of 2015 concerning the Indonesian National Police where Bhabinkamtibmas carries out visits to the community to listen to residents' complaints. community problems and maintaining friendly/fraternal relations. The task of Bhabinkamtibmas is to carry out and assist in solving a problem faced by the community in its

target area as well as to regulate and safeguard community activities in its implementation as the results of an interview with one of the community leaders (Mr. Mustapa) stated that: Bhabinkamtibmas along with the village head and Babinsa collaborate with the community to solve the problems experienced by its citizens. Furthermore, to ensure that the target area is safe, Bhabinkamtibmas makes an appeal or conveys it to the community and also carries out patrols throughout the area (Interview on Saturday, August 26 2023).

This is the aim of community policing to create a safe, orderly and peaceful society so as to increase public trust in the police. The realization of security and order in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency is the duty and responsibility of Bhabinkamtibmas. It is hoped that it will continue and Bhabinkamtibmas guarantees the comfort of the community in the area by carrying out activity programs and being a community partner in dealing with social problems that can disturb order, and community security in order to create a sense of security, order and tranquility. From the Bhabinkamtibmas side, they received information regarding the occurrence of criminal acts as a result of an interview with one of the youth leaders (Mr. Nasriadi) who stated that: The community will report to Bhabinkamtibmas if a criminal act occurs so that the community can receive direction and guidance so that problems can be resolved (Interview on Saturday August 26, 2023).

One of the duties of Bhabinkamtibmas is to receive information regarding the occurrence of criminal acts, this is intended so that every problem that occurs can quickly find a solution by prioritizing the principle of peace. In addition, Bhabinkamtibmas also receives complaints about problems from the community and carries out patrols in the community. With the presence of Bhabinkamtibmas, it is hoped that preventive efforts can be made against criminal acts in the area of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency. With the low level of criminal acts that occur, repressive actions will be lower. Repression is an act of social control carried out after a criminal act has occurred. From the side of Bhabinkamtibmas, it provides temporary protection to people who are lost, victims of crime and also violations as the results of an interview with one of the female figures (Mrs. Hasma) stated that: What Bhabinkamtibmas does if someone is lost is to find out the person's identity then disseminate information relating to the person's identity and secure the person (Interview on Saturday 26 August 2023).

Furthermore, the results of an interview with one of the RT Heads (Mr. Jumaedi) stated that: When a crime occurs, Bhabinkamtibmas helps by providing assistance to the crime victim and must also provide sanctions to the perpetrator. Likewise, if there are residents who commit violations, of course Bhabinkamtibmas gives a warning or reprimand (Interview Monday 28 August 2023). From the Bhabinkamtibmas side, it participates in providing assistance to victims of natural disasters and disease outbreaks, as per the results of an interview with one of the RK Chairmen (Mr. Ahmad) who stated that: If a natural disaster occurs, Bhabinkamtibmas will collect data on the victims so that they can immediately receive aid and assistance. Furthermore, if a disease outbreak occurs, such as during Covid-19, Bhabinkamtibmas will collaborate with

health workers to urge all residents to maintain health protocols to avoid transmission of Covid-19 (Interview on Monday 28 August 2023).

The presence of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency has had a significant influence in terms of increasing security and public order as well as reducing the level of crime and helping to solve social problems that occur. Based on the results of descriptive analysis and interview results, it shows that basically Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency has carried out his duties effectively, starting from making home visits to all areas of his assignment, carrying out and helping to solve a problem faced by the community in its target area, regulates and safeguards community activities, receives information regarding the occurrence of criminal acts, provides temporary protection to lost people, victims of crime and violations and participates in providing assistance to victims of natural disasters and disease outbreaks.

The results of this research are in line with previous research conducted by Chintya Cen (2020) which stated that the implementation of Bhabikantibmas duties was carried out with various activities with the community such as appeals, coaching, environmental security, house-to-house visits, mutual cooperation and various other activities. These activities realize the task of Bhabinkamtibmas as the spearhead of the National Police in building synergy with the community, building public awareness of applicable norms and laws as well as efforts to prevent crime and maintain the environment so that it remains safe, orderly, peaceful and conducive.

Implementation of Bhabinkamtibmas Functions in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency

The results of the descriptive analysis show that the average effectiveness of implementing the Bhabinkamtibmas function in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency is 2.83 or is in the effective category. This shows that all the duties of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency have been carried out effectively, as the results of an interview with the Secretary of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency (Mr. Haswar Haeruddin) stated that: Bhabinkamtibmas will provide guidance and counseling in in the field of law and kantibmas to the entire community to increase awareness of law and kantibmas. This guidance and counseling is usually carried out through village forums, at mosques, schools or in community groups (Interview on Friday 25 August 2023).

Through this community service counseling activity, it is intended to uphold the community's habit of obeying the law and carrying out regular socialization by involving all levels of society so that the law can be implemented effectively as a means of regulating community behavior so that safe, conducive and peaceful environmental and community conditions can be created. From the side of Bhabinkamtibmas, it encourages the implementation of environmental protection systems and community activities as per the results of an interview with one of the RK Chairmen (Mr. Ahmad) who stated that: Bhabinkamtibmas often gives directions or encouragement to the

community to carry out siskamling or night patrols with the aim of maintaining the security of residents (Interview Monday 28 August 2023).

Community development is carried out by encouraging the community to carry out security and social security activities with the aim of maintaining a conducive and safe state of community service and social security. Security and order can be realized if the entire community can behave in accordance with the conditions that have been determined and avoid actions that are against the law. From the side of Bhabinkamtibmas, it provides police services to people who need it, as per the results of an interview with one of the RT Heads (Mr. Jumaedi) who stated that: One form of Bhabinkamtibmas service to the community is providing norms regarding legal rules and will also improve them so that they do not commit applicable violations. (Interview on Monday 28 August 2023).

Bhabinkamtibmas as part of the police is a state tool that is assisted by the community by upholding human rights, providing protection, guidance and service to the community. Bhabinkamtibmas mobilizes positive community activities as the results of an interview with one of the youth leaders (Mr. Nasriadi) who stated that: Bhabinkamtibmas often participates in various community activities such as mutual cooperation, maintaining security during family celebrations or other activities (Interview Saturday 26 August 2023). Bhabinkamtibmas has a role as a promoter in dynamizing positive community activities. To carry out its functions, Bhabinkamtibmas invites the community to carry out various activities such as mutual cooperation and social service. Mutual cooperation and social service activities are carried out at certain times and also follow the issues/problems occurring at that time. This activity also collaborates with other related agencies.

In terms of coordinating efforts to develop Kamtibmas through village officials and other related parties, as the results of an interview with one of the community leaders (Mr. Mustapa) stated that: Bhabinkamtibmas coordinates with village officials by connecting or attending directly to the village office to discuss issues. -currently developing issues (Interview on Saturday 26 August 2023). The function of coordinating efforts to develop social security and order with village officials, Babinsa and other related parties has been carried out by Bhabinkamtibmas in the jurisdiction of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency. Activities related to this function are coordinator meetings, basic Bhabinkamtibmas skills training, development plan deliberations (musrembang), and prayers with local residents. One of the aims of carrying out this activity is to increase solidarity and synergy between the National Police and the community.

In terms of carrying out consultations, negotiations, mediation, facilitation, motivation to the community in Harkamtibmas and solving social crime problems as the results of an interview with the Head of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency (Mr. Hariadi) who stated that: Bhabinkamtibmas always provides consultations to the community such as consultations land issues and other legal issues and Bhabinkamtibmas helps the community in

negotiating regarding compensation issues, negotiating about misunderstandings between residents, as well as Bhabinkamtibmas mediating if there is a community that needs it, for example, if there is a dispute between the two parties, Bhabinkamtibmas brings together both parties to find a solution to the problem. (Interview on Friday 25 August 2023). Bhabinkamtibmas has the function of mediating and facilitating solving problems that occur in society. Activities that often occur in society are differences of opinion between residents, being offended by each other, even household problems such as domestic violence, husband-wife disputes, and so on. The implementation of this function is carried out by Bhabinkamtibmas personnel by solving problems, easing situations that are not conducive, and acting as mediators in conflicts between parties.

Furthermore, an interview with the Secretary of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency (Mr. Haswar Haeruddin) stated that: Bhabinkamtibmas facilitates the community such as helping the community in processing documents or files as well as other arrangements both at the village office and at the police station (polsek) Bhabinkamtibmas always provides motivation for the community to remain enthusiastic about working and fulfilling life's needs, inviting parents and youth to work together to produce something and become a great and achieving generation (Interview on Friday, August 25 2023).

In order to carry out the functions of consultation, negotiation, mediation, facilitation, motivation to the community, a Bhabinkamtibmas must have various skills such as early detection, social communication, negotiation and mediation, leadership and social problem solving. Other skills that a Bhabinkamtibmas must have, include: skills to handle conflict and differences in perception, skills to build teams and manage dynamics and foster group motivation, skills to understand and respond appropriately to diversity/pluralism and the principle of non-discrimination, skills in implementing community police strategies and human rights outcomes and gender equality, skills in handling and treating vulnerable groups and mastering interpersonal skills.

Based on the results of descriptive analysis and interview results, it shows that basically Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency has carried out its duties effectively starting from guiding and counseling in the field of law and Security and Community Security to increasing legal and Security and Community Security awareness by upholding Human Rights or Human Rights, disseminating various information regarding the policies of the National Police leadership relating to the Maintenance of Community Security and Order or Harkamtibmas, encouraging the implementation of security systems in environmental security and community activities, providing police services to communities in need, mobilizing positive community activities, coordinating efforts to develop Community Security and Order. through village officials and other related parties as well as carrying out consultations, negotiations, mediation, facilitation, motivation to the community in Harkamtibmas and solving social crime problems

The results of this research are in line with previous research conducted by Dodi Ramayana, et al (2021) which states that optimizing the performance of the Bhabinkamtibmas function at the South Sumedang Police, North Sumedang Police and Cimalaka Police is in accordance with standard operational procedures where the public already knows the whereabouts of Bhabinkamtibmas members in the area. mentored, active in expressing opinions, always present when asked by village/district officials, providing an influence on increasing community insight in the field of social security, social security, active in dealing with victims of disasters or natural disasters, and assisting in solving community problems.

4.2. Factors that support and hinder the effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency. Supporting factors

Based on interviews with observations at the research location, it shows that there are several factors that support the effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, including:

- 1. Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency has been on duty for approximately 10 years so that he has complete control over his assigned area by understanding geography, natural resources and population characteristics.
- 2. Availability of supporting facilities and facilities such as complete clothing for personnel, motorized vehicles, communication equipment (HP, HT and wireless), and other equipment that supports the implementation of Bhabinkamtibmas duties and functions.
- 3. The community supports every Bhabinkamtibmas activity so that the community tends to be willing to cooperate and obey the applicable legal regulations, where every presence and activity of Bhabinkamtibmas is welcomed positively by the community so that they help maintain a safe and orderly environment

Obstacle factor

- 1. Based on interviews with observations at the research location, it shows that there are several factors that hinder the effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, including:
- 2. Bhabinkamtibmas officers in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency have quite a large working area in other villages in Tondong Tallasa District.
- 3. The topography of Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, which is mountainous, requires quite a long time when carrying out patrols.
- 4.3. Efforts made to increase the effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency.

 Based on the supporting and inhibiting factors, the efforts made to increase the effectiveness of the implementation of the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, include:

- 1) There needs to be synergy and cooperation between Bhabinkamtibmas and the village government in an effort to create security and order in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency
- 2) Encourage and increase support from the entire community at large and in general to facilitate the implementation of the duties and functions of Bhabinkamtibmas.

5. Conclusion

The effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency is on average 2.80 or is in the effective category. Factors that support the implementation of the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency consist of: a) Bhabinkamtibmas controls the area of its duties; 2) Availability of supporting facilities and facilities; 3) Community support, while the factors that hinder the implementation of the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency consist of: a) the fairly large work area and b) the topography of Bulu Tellue Village. Efforts made to increase the effectiveness of implementing the duties and functions of Bhabinkamtibmas in Bulu Tellue Village, Tondong Tallasa District, Pangkep Regency, include: a) the need for synergy and cooperation between Bhabinkamtibmas and the village government; b) encourage and increase support from the entire community at large and in general.
